PURPOSE:

To request cash in transit banking services for Registration and Licensing offices in Mt. Frere (KwaBhaca).

BACKGROUND:

Umzimvubu Local Municipality operates the motor vehicle Registration and Licensing Authority under agency from the Provincial Department of Transport. In terms of the SLA moneys collected must be deposited into the provincial DoT banking account either daily or every second day. ULM banks theirs daily.

TERMS OF REFERENCE:

- 1. Banking of cash, coins and cheques five days a week at Mt Frere Standard Bank.
- 2. Return to ULM with proof of banking (Banking deposit slips) daily.
- 3. The services shall include:
 - Supply of tamper proof cash carrying containers.
 - b. Own insurance of cash in transit to the amount of R100'000.00.
- 4. The contract will be for a period of one year (months) renewable for a further one at ULM sole discretion.
