TERMS OF REFERENCE FOR SUPPLY & INSTALLATION OF ALARM SYSTEMS FOR EMAXESIBENI & KWABHACA MUNICIPAL OFFICES.

Request for supply & installation of alarm systems for eMaXesibeni and KwaBhaca Municipal (On strong room, and office at eMaXesibeni, one strong room and one prefab at KwaBhaca). After installation, the alarm systems to have a guarantee of not less than two years.

## Terms of Reference:

- Passive infrared (PIR) movement sensors with a lens for solid curtain coverage installed in such a manner that covers ceiling of the building;
- Every movement sensor shall be equipped with a tamper-proof device;
- If the alarm is activated; it must ONLY be possible to reset it with a remote key or a code adjustment;
- Independent functioning in case of power failure for a duration of at least 10 hours;
- The control units MUST be installed within the safeguarded area or be equipped with a tamper-proof device;
- An automatic telephone contact number which effects contact to the applicant or any other responsible person, or which MUST be installed within the area of safeguarded and be equipped with tamper-proof device;
- A siren with a SAFE frequency level of at least 93 decibels with a flashing red light which MUST be installed within the safe tamper-proof device;
- Panic buttons for these areas: eMaXesibeni (DLTC and RA), and KwaBhaca (RA, and Revenue office).
   Panic buttons to have automatic telephone contact unit which effects contact person or any other responsible person.
