The above matter bears reference.

This communique serves to request your office to solicit proposal from suitable and qualified services providers for the provision of <u>parking meter management services</u> for a period of two years in Mount Frere.

The proposal must include the following:

- 1. The number of parking meters to be used to cover the town.
