PURPOSE

LEGAL / STATUTORY REQUIREMENTS

Municipal Structures Act, No. 117 of 1998 as amended

BACKGROUND / REASONING

The Speaker of Umzimvubu Local Municipality submitted a letter of resignation with immediate effect.

Section 39 (a) of the Municipal Structures Act provides that the Speaker of a municipal council vacates office during a term if that person resigns as the Speaker. This means that the Council currently has no Speaker as the resignation created a vacuum.

In terms of Section 36 (1) - each municipal council must have a chairperson who will be called the Speaker. Subsection (2) of the same Act states that at its first sitting after its election or when necessary to fill a vacancy, a municipal council must elect its speaker from among the Councillors. Subsection (3) indicates that the municipal manager of the municipality or, if the municipal manager is not available, a person designated by the MEC for Local Government in the province, presides in the election of the Speaker.

Proceedings on the election of the Speaker will be conducted in line with schedule 3 of the Municipal Structures Act.
